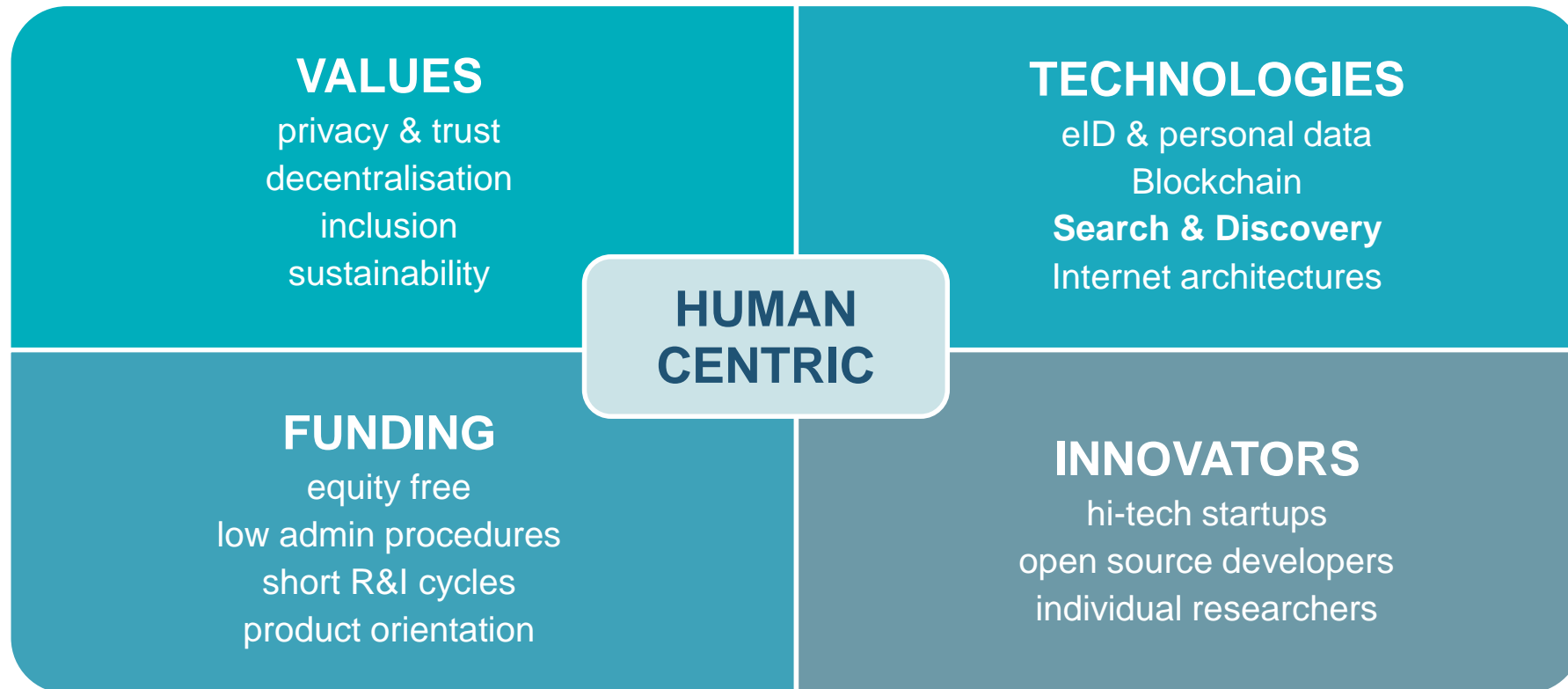
## Restoring **trust**

# NEXT GENERATION SEARCH AND DISCOVERY: A LOT OF WORK AHEAD

Key areas of work:

- Achieve more **agency, autonomy** and **resilience** through **open source** technologies for search, avoiding monopolisation and pitfalls of personalisation such as echo chambers
- Implement **alternative filtering and ranking algorithms** to better assist end-users
- Link, enrich, understand and discover **content and communities** through use of **open standards** for annotation and metadata;
- Create safe **decentralised market places** where anyone has the **same opportunities**
- Improve usability of non-traditional modalities of search, such as **voice search**
- **Increase** users **privacy**

# NGI ZERO DISCOVERY



## Technologies improving search and discovery

- Total budget for projects 2018-2021: **€5.6m**
- Projects focus on new ideas and core open source technologies improving search and discovery.
- **57 ongoing bottom-up projects** (April 2020) and growing, on different technology layers: from **network infrastructure** to **middleware**, from **Data&AI** to **services** and **applications**
- Funded projects include:
  - [Searx](#): a metasearch engine that will soon have the ability to integrate your own **private search** domains. [Mailpile](#) will integrate your private email search into that, and so will [Nextcloud](#).
  - The [Green Web Foundation](#) will make it possible to elevate search results from ecofriendly hosters.
  - [minedive](#) is an experimental P2P privacy conscious distributed search engine embedded in a browser extension.
  - [NextApps](#), creators of [flexsearch](#) are experimenting with new ranking algorithms in **Tantum Search**
  - The [DAT Foundation](#) is building an accessible set of tools for creating secure community-run and private file storage on the DAT protocol.

# SEARCH AND DISCOVERY – IDEAS FOR THE FUTURE

(Results of the workshop on search and discovery 13-Nov 2019)

- **European “Open Search” research programme:** a large open search-focused research programme, which would fund open source solutions in this space
- **European web index:** coordination and funding for the development of a sovereign European web index. Even many of the alternative, more privacy-sensitive search engines still rely on the web indexes of the large incumbents.
- **Semantic web:** Continued investment in making data and information online more machine readable will improve the quality and efficiency of search
- **User-centric:** With more and different types of devices entering the market, we will need to rethink how we design solutions and new tools - and put the user at the centre of these new design approaches (not the device)
- **Data control:** Fund research providing a really easy way for a user to control what data he/she will share across websites and applications
- **Alternative recommendation/ranking algorithms:** Move beyond “page rank” systems based on opaque and profit-optimised algorithms

# NGI IN HORIZON EUROPE

- Horizon Europe vision: a sustainable, fair and prosperous future for people and planet based on European values
  - Tackling climate change
  - Helping to achieve Sustainable Development Goals
  - Boosting the Union's competitiveness and growth
- NGI is fully in line with this vision; it is an intervention area in:
  - Pillar 2 'Global Challenges and European Industrial Competitiveness'
  - Cluster 'Digital, Industry and Space'
- 2020: Strategic Plan 2021-2024 >> Work programme 2021-2022
- 2021: Start of Horizon Europe (first Calls for Proposals)
